1. **Pontoon Ride:** Tabled.
2. **Youth Hunt:** Tabled.
3. **Bucks Night:** As of now, Buck's Night is going to be held as normal. More discussion was had on planning for the event. The committee will get together to start the process.
4. **Habitat/Fisheries:** There has been a lot of garbage being left at the North Landing by the bathrooms. Discussion was had on how to mitigate the problem. A couple members will attend the next Town of Alden meeting to talk with them on how to fix the issue. Al Nerby brought up to the club that a section of the Apple River between Cedar Creek Inn and the Outpost has a considerable amount of trash in it. Discussion was had and an idea to start coordinating a river clean-up day with the assistance of other local partner clubs. The committee will discuss and coordinate an event.

New Business:

1. Duck Blind on WPA-The club approved to donate \$4500 last fall for the initial project. The project went over budget, but the Friends of the St. Croix WMD is going to cover the difference. The blind is out there, but the pathway and setting the blind in place will take place in the next couple weeks.
2. Star Prairie Land Preservation Trust-Record Storage-The club was asked by the SPLPT if they could store their records in the basement of the town hall. The club has approved to allow the SPLPT to store their records in the basement of the town hall, as long as they provide their own filing cabinet and do not hold our club liable for damages that may occur.
3. New Richmond Health Center-The health center reached out to Chuck Magoon asking if the club had any ideas on how we could entertain or do something special for the seniors. Discussion was had, but there were no decisions made at this time.

4. New Richmond Chamber of Commerce Membership-Craig shared that our annual membership was due for the NR Chamber. The club approved renewing the membership at a price of \$97.
5. August Meeting Location-A decision was made by the club to hold the August meeting at Menke's Garage on the South end of Cedar Lake.
6. Craig Jameson was drawn for the attendee drawing of \$100 and was not present. The drawing for the August meeting will be for \$120.
